Mr. Cundiff motioned to approve the March 20, 2025 meeting minutes as presented.

Mr. Ritchie seconded the motion, and the remaining Board members agreed.

#### III. OLD BUSINESS

A. <u>Discussion and Action on the Small Business Statement After Public Hearing and Proposed New Rules and Regulations Relating to the Use of Parks and Park Facilities Peddlers and Concessionaires, Part VI – Rules and Regulations Governing the Operation of Concessionaires at the Spouting Horn Park, promulgated by County of Kauai, Department of Parks and Recreation</u>

Discussion leader Ms. Ige briefly stated that the proposed rules relate to bids for the concessionaires at the Spouting Horn. Mr. Patrick Porter, Director of Parks and Recreation for the County of Kauai, provided the history of this tourist attraction known as the Spouting Horn Park.

Initially, although there were only governing County Codes, it was subsequently recommended that administrative rules be created. The proposed rules mostly clean up the ordinances as they generally follow the conditions of the Code.

Ms. Ige added that the Board's agenda packet has a list of the concession procedures and fees. The proposed minimum bid of \$3,500 fixed per month fee was discussed at length as it was increased from approximately \$2,500 - \$3,000. While the amount of space per square footage appears high, Mr. Porter stated that concessionary owners were amenable to the price increase and are longing to go back to the concessionary stands.

Despite the normal, legal process of providing notice of these rules for public hearing, Mr. Porter stated that a "handful" of small business vendors are in touch with his office and familiar with the proposed rules. Also stated was that to change the upfront bid price of \$3,500, the administrative rules would need to be amended.

Mr. Cundiff motioned to send the proposed new rules to the Kauai Mayor for adoption. Second Vice Chair Morioka seconded the motion, and the Board members unanimously agreed.

#### V. LEGISLATIVE MATTERS

- A. Update on the following:
  - Senate Bill 1343 SD1 HD2 Relating to the Small Business Regulatory Review Board – Amends the quorum requirements to do business and validate acts of the Small Business Regulatory Review Board.

The Senate and the House do not agree on the last version of SB 1343 SD1 HD2.

Under Section (d) of the Board's statute, the House proposed changing wording of the bill to "(d) A majority of all the members appointed 'or' confirmed to serve on the board, to no less than five." As the Senate disagrees, this measure is scheduled for Conference Committee. While House conferees were scheduled, Senate conferees have yet to be scheduled.
